Following proposed amendment was adopted

Article 7

(iv) Election procedure

(e)in case of contest, election shall be held by ballot

Proposed Amendment (iv) Election procedure

(e)in case of contest, election shall be held by E voting or by ballot.

· 1) In case of E voting registration of eligible member with AOGS will be compulsory.

Only registered eligible member will receive E ballot and will be able to vote.

2) In case of election by ballot, photo ID shall be compulsory to get ballot

Article 6: Membership (I) Eligibility

On payment of prevailing fee Gynaecologist post graduate degree or diploma holder can be a member of AOGS or any other degree holder of Obstetrics and Gynecology recognized by MCI can also be a member of AOGS (i.e., MRCOG etc.). Others can become

Any new member of AOGS should be holding a post graduate degree or diploma in OB GYN. or should be registered with a recognized university as a bonafide student of a post graduate course (Recognized by MCI) A Gynaecologist and Obstetrician who is willing to become member of AOGS must be practicing in Ahmedabad district. He should not be the member of another FOGSI affiliated Society as dual membership is not allowed. If the person is already member of other Federation of Obstetric and Gynaecological Societies of India (FOGSI) affiliated Society still wants to become member of AOGS, He can become associated member without voting right and without eligibility to contest any election

Proposed Amendment

There will be two category membership as it is in FOGSI

Category A

On payment of prevailing fee any eligible Gynaecologist holding recognized post graduate degree, diploma, DNB or any other degree (i.e., MRCOG, FRCOG etc.) in Obstetrics and Gynaecology recognized by Medical council of India (now: National Medical commission) can become member. Eligible member who is either residing or practicing or serving in Ahmedabad city or Ahmedabad district (decided by postal pin code) will be category A member.
