Eligibility Criteria and Rules for elections for the posts are as follows:

- 3) The candidate must file duly filled and signed nomination form for the post within stipulated time and it shall be seconded by two other life members of AOGS.
- 4) One candidate can file nomination for one post only otherwise the candidate will be held ineligible for all posts.
- 5) In case of contest election shall be held by ballot.
- 6) If there is only one valid candidate for the post he/she shall be declared elected by the President of AOGS.
- 7) No electoral literature or material will be allowed inside premises for voting. Any member violating this rule will be disqualified and his vote will stand as cancelled.
- 8) Nomination fee for each post shall be Rs. 2000/- which will be non-refundable even in case of withdrawal.
- 9) In case of equal votes President of AOGS will cast the deciding vote. This will be over and above his own vote as a member.
